

A TASTE OF VALDOSTA RESTAURANT PARTICIPATION AGREEMENT

THIS AGREEMENT, entered into this the _____ day of _____, 2011 by and between Quota International of Valdosta, Inc. (hereinafter referred to as Quota), and _____ (hereinafter referred to as "Participating Restaurant"), as follows:

1. The Participating Restaurant has read, and fully understands, the Exhibitor Rules and Regulations, which are attached hereto as an Exhibit and make a part hereof by express reference thereto. Quota and the Participating Restaurant agree that the operation of the Participating Restaurant's tasting center during this event shall be governed by said Exhibitor Rules and Regulations.
2. The Participating Restaurant agrees to participate in a dining and entertainment experience organized by Quota and advertised as "A Taste of Valdosta" (hereinafter referred to as "this event"), which event shall take place on Saturday, **April 2, 2011**, at the James H. Rainwater Conference Center in Valdosta, Georgia.
3. Quota agrees to reserve for the Participating Restaurant, and the Participating Restaurant agrees to utilize during this event, one tasting center, the size as described in the attached Exhibitor rules and Regulations. Said tasting center shall be assigned by Quota to each Participating Restaurant on the basis of availability of space.
4. Each Participating Restaurant agrees to pay Quota a **nonrefundable booth deposit** of \$135.00. This deposit shall be paid no later than **February 28, 2011** and should be paid by check made payable to Quota International of Valdosta, Inc. No reservation of space shall be made without payment of the booth deposit.
5. Each Participating Restaurant will receive newspaper and radio advertising, provided booth deposit has been paid by **February 28, 2011**.
6. This agreement, including the attached Exhibitor Rules and Regulations, the attached Exhibitor Equipment Form and the attached Exhibitor Menu Form, shall constitute the entire agreement between the parties hereto, and any and all verbal understandings of agreements previously entered into are considered merged into this written form. Said agreement shall not be altered except by a writing executed by Quota and the Participating Restaurant.
7. Participating Restaurant shall furnish to Quota a Certificate of Insurance, a completed Menu Form, food permit from the Health Department, and a completed Equipment Form, no later than **March 1, 2011**. Thereafter, said Menu Form and Equipment Form shall not be subject to change without the prior written consent of Quota.
8. If the Participating Restaurant fails to show at this event on April 2, 2011 without good cause, the Participating Restaurant shall not be invited back to subsequent Taste events or shall be charged a booth deposit of three times the normal deposit. Good cause shall be in the discretion of the Quota Taste of Valdosta Steering Committee.
